DEFINITIONS

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

8. EXPOSURE CONTROLS: PERSONAL PROTECTION

National Exposure Standards

The time weighted average concentration (TWA) for this product is: 10ppm 8 hours, which means the highest allowable exposure concentration in an eight-hour day for a five-day working week. The short term exposure limit (STEL) is: 15ppm 15 minutes, which is the maximum allowable exposure concentration at any time. Replacing a TWA or STEL value for some products is a Peak Limitation value (Peak): 67.5mg/m³ 8 hours applies in this case.
